Conserving the Chesapeake – Accelerating Beyond 2025: Toward 30x30

November 9 - 10, 2022

National Conservation Training Center, Shepherdstown WV

Overview

Partners throughout the Chesapeake have been achieving and setting examples for large landscape conservation for many years. Yet amidst rising ecological, political, and social stressors, it is urgent to take stock of our resources and determine ever more effective means to achieve collective impact to stay ahead of the threats and protect our future.

The Chesapeake Bay Watershed Agreement sets out goals and metrics for Bay conservation and restoration through 2025, aiming to protect 2 million acres above a 2010 baseline. Science tells us that to perpetuate biodiversity and mitigate climate change impacts, we need to do even more, protecting a more significant portion of the watershed by 2030 and beyond. The U.S. aims to conserve at least 30% of lands and waters by 2030 ("30x30") as part of an international push toward sustainability. The Chesapeake Conservation Partnership (CCP) as a partnership has committed to striving to reach the 30x30 goal for the Bay watershed, with some aiming for as much as 50% in the ensuing years. Though the targets may vary among partners, we know that we need to urgently accelerate the rate and scale of lands that are protected, to meet several complementary benefits.

How can we use the power of our collaborative – positioning our resources, relationships, and programs – to achieve more, faster, together? How are we centering people and equity in our work? How can CCP serve to catalyze and contribute to progress as a backbone?

At the meeting, we aim to:

- Energize our thinking with some inspiring examples from different landscapes.
- Devise a common framework to provide a unified basis of collective action and support.
- Spark state-level 30x30 strategies which will guide and inform our collective work.
- Develop clear next steps.

1:15 Building a 30x30 Plan: Lessons from California

California has developed an ambitious, multi-faceted plan to achieve their 30x30 goal. Dr. Jennifer Norris, Deputy Secretary for Biodiversity and Habitat, will join us via Zoom and provide an overview of their efforts with an emphasis on lessons learned.

Jennifer serves as Deputy Secretary for Biodiversity and Habitat at the California Natural Resources Agency. She leads the state's 30x30 initiative and oversees "Cutting Green Tape" in support of landscape-scale habitat restoration. Jennifer has held numerous federal and state government positions, including most recently as supervisor of the Sacramento Office for the United States Fish and Wildlife Service. She has extensive experience in conservation policy, endangered species protection, and ecosystem management. She holds a B.S. in Resource Policy and Planning from Cornell University, an M.S. in Conservation Biology from the University of Michigan, and a Ph.D. in Ecology from the University of New Mexico. When she is not at work, she can be found exploring wild beaches, forests, and deserts with her family.

Brad Rogers, Executive Director of the South Baltimore Gateway Partnership, will present the Reimagine the Middle Branch project, which is engaging and connecting people, parks, projects & programs in South Baltimore communities.

Phil Wenger, CEO of the Lancaster Conservancy will share how partners protected a combined 2,200 acres of contiguous forest through multiple acquisitions which has now led to a new state park with the working name of the Susquehanna Riverlands State Park.
