3:05 2025 and Beyond: CESR Report and the Chesapeake Bay Program. What's working and what's not in land conservation strategies in the watershed?

This is our 14th annual meeting. We have made tremendous progress. 9.1 million acres protected, and collectively, we know we need to do more, faster and more equitably. We will start this session with table conversations focused on the long view, what has worked and what might we do better or differently in our land conversation strategies moving forward.

The Bay Program, as a whole, is also engaging in this analysis. The recently released CESR report (Comprehensive Evaluation of System Response) offers a detailed analysis of progress and has recommended significant changes in Bay program strategy. A Beyond 2025 Steering Committee is convening regularly to chart a course forward. Kristin Saunders (UMCES) and Wendy O'Sullivan (NPS) will provide an overview of these efforts.

After Q&A, we will focus on ensuring that land conservation's essential role in Bay health is fully recognized and the strategies are aligned.

Tools You Can Use (In Turner Instructional East)

Model Easements & Tools - Location: Room 103 Explore WeConservePA's suite of 170 guides and customizable model legal documents that greatly facilitate conservation transactions from Alaska to Florida, including the Model Grant of Conservation Easement and Declaration of Covenants. (Andy Loza, WeConservePA)

The Chesapeake Bay Targeting Tools Portal - Location: Room 105: This portal serves as a single point of entry for a range of web-based decision support tools used or developed by the Chesapeake Bay Program Partnership, its Goal Implementation Teams and associated Workgroups. The Portal provides access to tools to identify and evaluate conservation opportunities throughout the Bay watershed. Tools are organized based on relevance to high-level topics, including water quality; fish, wildlife, and habitats; land conservation; and benefits to people. This station will provide an overview of the Portal and its navigation, as well as a deeper dive into one or more tools of potential interest to the audience. (John Wolf)

Parcel Prioritization Tool used by the Potomac Conservancy - Location: Room 107: High-value lands for protecting water quality in the Potomac River watershed. The mapping covers Maryland, Virginia, and West Virginia.(Hedrick Belin, Potomac Conservancy and Steve Storck, Chesapeake Conservancy)

Green Space Equity Tool - Location: Room 111: This tool was built by the Chesapeake Conservation Partnership to highlight low-income communities and communities of color with limited access to open space in the watershed. The Trust for Public Land has mapped park access for every urban area in the U.S., including Puerto Rico. The ParkServe mapping platform helps you pinpoint park investments to address park needs, climate, equity, and health. Solar Siting - Location: Room 112: Solar Siting has become an increasingly significant challenge in multiple states across the watershed. In this workshop, we will focus on solar siting tools created for Baltimore/Baltimore County and St. Mary's County Maryland that analyzes optimal solar siting locations.
